The Grand Jurors, in the name and behalf of the citizens of Georgia, charge and accuse **JESSE CASTILLO** with the offense of **Malice Murder**, for that the said accused, in the County aforesaid, **on or about the 27th day of February, 2021**, did unlawfully, with malice aforethought, cause the death of Michael Griffith, a human being, by shooting said victim with a .22 caliber handgun, in violation of O.C.G.A. 16-5-1(a), contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 2

The Grand Jurors, in the name and behalf of the citizens of Georgia, charge and accuse **JESSE CASTILLO** with the offense of **Felony Murder**, for that the said accused, in the County aforesaid, **on or about the 27th day of February, 2021**, while in the commission of the offense of aggravated assault, a felony, in violation of O.C.G.A. 16-5-21(a)(2), did cause the death of Michael Griffith, a human being, by using a .22 caliber handgun, a deadly weapon, to commit an assault on said victim, involving an attempted violent injury, by shooting said victim, in violation of O.C.G.A. 16-5-1(c), contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 3

The Grand Jurors, in the name and behalf of the citizens of Georgia, charge and accuse **JESSE CASTILLO** with the offense of **Aggravated Assault**, for that the said accused, in the County aforesaid, **on or about the 27th day of February, 2021**, did make an assault, involving an attempted violent injury, upon the person of Michael Griffith with a .22 caliber handgun, deadly weapon, by shooting said victim, in violation of O.C.G.A. 16-5-21(a)(2), contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 4

The Grand Jurors, in the name and behalf of the citizens of Georgia, charge and accuse **JESSE CASTILLO** with the offense of **Aggravated Assault**, for that the said accused, in the County aforesaid, **on or about the 27th day of February, 2021**, did make an assault upon the person of Phillip Williams with a .22 caliber handgun, a deadly weapon, when he placed said victim in reasonable apprehension of immediately receiving a violent injury by pointing said handgun at said victim while threatening to shoot said victim, in violation of O.C.G.A. 16-5-21(a)(2), contrary to the laws of said State, the good order, peace and dignity thereof.

The Grand Jurors, in the name and behalf of the citizens of Georgia, charge and accuse **JESSE CASTILLO** with the offense of **Possession of Firearm During Commission of a Felony**, for that the said accused, in the County aforesaid, **on or about the 27th day of February, 2021**, did unlawfully have on his person a .22 caliber handgun, a firearm, during the commission of the crime of murder, a felony, a crime involving the person of Michael Griffith, in violation of O.C.G.A. 16-11-106, contrary to the laws of said State, the good order, peace and dignity thereof.
